Mission Impact

INTER-AMERICAN FOUNDATION (IAF)

The Inter-American Foundation (IAF) is an independent, U.S. foreign assistance agency that awards grants throughout Latin American and the Caribbean. The IAF has over 400 active grants and has awarded nearly 6,000 grants since its creation in 1969.

IAF was seeking a vendor who could provide a Commercial-off-the-Shelf (COTS), cloud-based full lifecycle Grants Management System (GMS). GovGrants was able to deploy from Contract Award to Production in one year and represents the Agency's first multilingual grants management system that allows IAF to accept grant proposals directly from prospective grantees. GovGrants adheres to FIBF, established recently by the Federal Government through its Grants QSMO, with specific emphasis on Discretionary Grants. GovGrants provides secure and easy financial integration with the Oracle Financial System hosted by BFS and other external systems and accommodates all data migrated from IAF's existing grants system.

NORTHERN BORDER REGIONAL COMMISSION (NBRC)

NBRC is a Federal-State partnership for economic and community development in northern Maine, New Hampshire, Vermont, and New York. The NBRC mission is to catalyze community vitality and economic prosperity in the northern border region with flexible funding and strategic support. NBRC sought a modern, secure, full lifecycle SaaS solution to facilitate compliance with government regulations and statutes; increase effectiveness, efficiency, and accountability; and allow automated processing and oversight of the grant management workflows for each of their programs. In 2024, REI configured and implemented GovGrants in under 12 months to receive approximately 200-400 project proposals per year across three different grant programs, awarding up to 75-85 new awards per year, totaling approximately \$50 million. GovGrants has already demonstrated an improved overall user experience for efficiently managing grants and created significant time savings on the application process for NBRC staff and its grantees.
